**FIRST AMENDMENT TO
DECLARATION OF COVENANTS, CONDITIONS,
RESTRICTIONS, AND EASEMENTS FOR
CORMONT RESIDENTIAL CONDOMINIUMS**

[Cormont at Deer Valley East Village – Residential Towers 1, 2, 3, 4, and 5]

THIS FIRST AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS, AND EASEMENTS FOR CORMONT RESIDENTIAL CONDOMINIUMS (this "First Amendment"), dated as of the 5 day of June, 2026, entered into and executed by **RPE22 MAYFLOWER CONDOMINIUMS LLC**, a Delaware limited liability company ("Declarant"), and **CORMONT RESIDENTIAL ASSOCIATION INC.**, a Utah non-profit corporation ("Association"), amends that certain Declaration of Covenants, Conditions, Restrictions, and Easements for Cormont Residential Condominiums, dated February 25, 2025, and recorded on February 26, 2025, as Entry No. 556349, in Book 1506, beginning at Page 1013, in the official records of the Wasatch County, Utah Recorder ("Official Records"), and that certain Supplemental Declaration to Declaration of Covenants, Conditions, Restrictions, and Easements for Cormont Residential Condominiums, dated December 10, 2025, and recorded on December 10, 2025, as Entry No. 567934, in Book 1539, beginning at Page 1667, in the Official Records, as the same may be further amended and supplemented from time-to-time (collectively, the "Residential Declarations"). All capitalized terms not otherwise defined in this First Amendment shall have the meaning ascribed to them in the Residential Declarations.

RECITALS

A. RPE22 Mayflower Condominiums LLC, a Delaware limited liability company, is the original and current "Declarant" under the Residential Declarations.

B. In addition, RPE22 Mayflower Condominiums LLC, a Delaware limited liability company, is the current and sole "Owner" of the entire Residential Project commonly referred to as the "Cormont at Deer Valley – Residential Condominiums" (or alternatively, the "Cormont Residential Condominiums").

C. Cormont Residential Association Inc., a Utah non-profit corporation, is the original and current "Association" under the Residential Declarations.

D. The Residential Declarations contain certain rights and reservations in favor of Declarant (including, the Special Declarant Rights) to, among other things, amend, supplement, and/or modify the Residential Declarations.

E. To the fullest extent permitted under the Residential Declarations or the Act, including, as part of the Special Declarant Rights and any other rights and reservations in favor of Declarant during the Declarant's Period of Control, Declarant desires to exercise its rights in favor of Declarant under the Residential Declarations to amend, supplement, and/or modify the Residential Declarations in accordance with the terms, conditions, and provisions of this First Amendment, to be effective upon the recordation of this First Amendment in the Official Records.

F. To the extent required under the Residential Declarations or the Act, including, under Section 17.2 of the Residential Declarations, the Owners of the Residential Project, by way of an affirmative vote of at least fifty-one percent (51%) of the votes allocated to all Residential Units, have agreed to consent to and support Declarant and the Association entering into this First Amendment in order to amend, supplement, and/or modify the Residential Declarations in accordance with the terms, conditions, and provisions of this First Amendment, to be effective upon the recordation of this First Amendment in the Official Records.

G. To the extent required under the Residential Declarations or the Act, the Association desires to acknowledge, agree with, and consent to this First Amendment.

H. Upon the recordation of this First Amendment in the Official Records, this First Amendment shall constitute an amendment to the Residential Declarations.

AMENDMENT

NOW, THEREFORE, the Declarant and the Association, hereby amend, supplement, and modify the Residential Declarations as follows:

1. Recitals. The Declarant and the Association hereby affirm the truth and accuracy of the foregoing Recitals, which are hereby incorporated by reference as part of this First Amendment.

2. Fractional Ownership Prohibited. Section 9.4 of the Residential Declarations is hereby deleted in its entirety and replaced with the following language:

9.4 Fractional Ownership Prohibited. It is the intent of Declarant and the Association that any and all fractional interest, timeshare interest, time-period regimes, and/or timesharing, interval ownership, private residence club, and/or other shared ownership regimes or comparable use programs are strictly prohibited with respect to any and all Residential Units within the Residential Project. No Owner of a Residential Unit

shall have the right to submit all or any portions of a Residential Unit within the Residential Project to any fractional, timeshare, time-period, interval, private residence club, and/or other shared ownership regimes or comparable use programs. Without limiting the generality of the foregoing, the following regime(s) and/or program(s) are specifically prohibited: (i) ownership of a Residential Unit by any entity (including, without limitation, any limited liability company, partnership, trust, joint venture, corporation, or any other form of business or legal entity capable of holding title to real property) where the ownership interests, membership interests, beneficial interests, or use rights in such form of business or legal entity are divided, allocated, or assigned among multiple parties based on specific time periods, rotating schedules, or any other arrangement or time period regime that results in the functional equivalent of fractional ownership, timeshare use, interval ownership, or other shared ownership regime or comparable use program; (ii) any agreement, arrangement, or understanding (whether written or oral) that grants multiple parties the right to occupy or use a Residential Unit on a time-sharing, rotating, or scheduled basis, regardless of how such arrangement is structured or documented; (iii) any transfer, assignment, or allocation of use rights to a Residential Unit that is separate from or independent of the transfer of fee title to a Residential Unit; and (iv) any marketing, advertising, sale, leasing, licensing, management, or operation of a Residential Unit in a manner that suggests or implies that fractional ownership, shared ownership, timesharing, and/or other shared ownership regimes, comparable use programs, or similar divided use rights are permitted. For purposes of this Section 9.4, an arrangement shall be deemed to constitute a prohibited fractional, timeshare, interval ownership, or other shared use regime or program if the practical effect of such arrangement is to divide or allocate use rights among multiple, unrelated parties on a time-period basis that is facilitated by an unrelated, third-party to operate or manage such arrangement, regime, and/or program, regardless of the legal structure employed. Any potential sale or transfer of a Residential Unit or purchase, acceptance, or acquisition of a Residential Unit by a limited liability company, partnership, trust, joint venture, corporation, or any other form of business or legal entity capable of holding title to real property shall first be approved in writing by Declarant during the Declarant's Period of Control or the Association (after the Declarant's Period of Control has expired), which approval may be granted, denied, or conditionally approved in the sole and absolute discretion of Declarant and/or the Association, as applicable.

3. Additional Acknowledgements. Section 19.3 of the Residential Declarations and each of those matters affecting the Residential Units and the Buildings, the Common Areas and Facilities, the Improvements, and the Residential Project that the Owners have been advised of and that the Owners have agreed to and acknowledged is hereby amended and expanded to include the following:

19.3.11 Smoking and Vaping Restrictions. Unless otherwise required by law to allow smoking or vaping in certain areas, smoking or vaping are not allowed or permitted within any of the Residential Units, the Buildings, the Common Areas and Facilities, the Improvements, and/or in any other locations within the Residential Project designated or identified by the Board of Directors. It is the intent of Declarant and the Association that smoking or vaping are allowed only in certain areas within the

Residential Project that have been designated by the Board of Directors for smoking or vaping, if any. The term “smoking” or “vaping” means the use or possession of a cigarette, cigar, pipe, e-cigarette, vapor devices, or any other item or apparatus containing any tobacco product while such item or apparatus is burning, igniting, vaporizing, or otherwise altering the state of the tobacco. Each Owner, to the fullest extent permitted by law, for itself and its Occupants, Permittees, successors, and assigns, hereby releases, waives, discharges, and covenants not to sue the Declarant, the Manager, and the Association from any and all claims arising from or relating to any right to a cause of action against the Declarant, the Manager, and the Association for any nuisance related to any tobacco, vaping, or other smoke that drifts into a Residential Unit from any other Residential Unit and/or any of the Buildings, Common Areas and Facilities, Improvements, or other locations within the Residential Project and holds the Declarant, the Manager, and the Association harmless for any claims or damages arising from or relating to smoking, vaping, and second-hand smoke. Declarant and the Association have made no representations, warranties, assurances, or commitments of any kind that the Residential Project will be a smoke-free environment. The Association may assess a fine to the Owner of a Residential Unit for each and every violation of this Section 19.3.11 in the amount of Two Hundred Dollars and No/100 (\$200.00) or such higher amount as is reasonably established and determined by the Association.

4. Amendment to the Residential Declarations. This First Amendment constitutes an amendment to the Residential Declarations. In the event of any conflict or inconsistency between the terms of this First Amendment and any other terms of the Residential Declarations, the terms of this First Amendment will govern and control.

5. Continued Effectiveness of Residential Declarations. Except as amended by this First Amendment, all terms and conditions of the Residential Declarations are hereby ratified and confirmed by the Declarant and the Association and remain in full force and effect.

6. Covenants Running with Land. The provisions of this First Amendment and the Residential Declarations shall run with and burden the Residential Project as a whole and shall be binding upon any and all Owners, Occupants, Permittees, and/or Mortgagees having any right, title, or interest in the Residential Project, or any portions thereof, including, their heirs, successors, and assigns and shall inure to the benefit of each party and owner thereof.

7. Recording. This First Amendment is hereby recorded against the entire Residential Project, including, without limitation, any and all Residential Units and the Buildings, the Common Areas and Facilities, and the Improvements, being more particularly defined and described on the attached Exhibit “A”.

8. Exhibits. Each Exhibit attached to this First Amendment is incorporated into this First Amendment by this reference.

9. Effective Date. This First Amendment shall be effective as of the date it is recorded in the Official Records (the “Effective Date”).

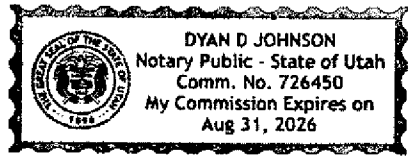

LEGAL DESCRIPTION OF RESIDENTIAL PROJECT

The real property referenced in the foregoing First Amendment as the “Residential Project” is located in Wasatch County, State of Utah and is more particularly described as follows:

FOR INFORMATION PURPOSES: The Residential Project (as a whole) is commonly referred to as the “Cormont at Deer Valley – Residential Condominiums” (or alternatively, the “Cormont Residential Condominiums”) and is part of the overall Cormont Project (as this term is defined in the Residential Declarations) that consists of a vertically stacked and horizontally integrated, mixed-use, convertible commercial, parking, and residential condominium project.

ALL OF THE RESIDENTIAL UNITS AND ALL REAL PROPERTY CONSISTING OF THE COMMON AREAS AND FACILITIES contained within the Cormont at Deer Valley Condominiums: Residential (also referred to as the “Cormont Residential Condominiums”), as the same are identified in the Cormont at Deer Valley Condominiums: Residential (Phase I) Plat, recorded in the Official Records on February 26, 2025, as Entry No. 556348, in Book 1506, beginning at Page 983, and that certain Cormont at Deer Valley Condominiums: Residential (Phase II) Plat, recorded in the Official Records on December 10, 2025, as Entry No. 567933, in Book 1539, beginning at Page 1615 (collectively, the “Residential Plats”) (as said Residential Plats may heretofore be amended or supplemented from time-to-time) and in the Declaration of Covenants, Conditions, Restrictions, and Easements for Cormont Residential Condominiums, recorded in the Official Records on February 26, 2025, as Entry No. 556349, in Book 1506, beginning at Page 1013, and that certain Supplemental Declaration to Declaration of Covenants, Conditions, Restrictions, and Easements for Cormont Residential Condominiums, recorded in the Official Records on December 10, 2025, as Entry No. 567934, in Book 1539, beginning at Page 1667 (collectively, the “Residential Declarations”) (as said Residential Declarations may heretofore be amended or supplemented from time-to-time).

TOGETHER WITH the undivided ownership interests in any applicable Common Areas and Facilities (as this term is defined in the Residential Declarations) that are appurtenant to said Residential Units, as more particularly identified and described in the Residential Plats and the Residential Declarations.

FOR INFORMATION PURPOSES: The Cormont Residential Condominiums and the Residential Units have been assigned (as of the Effective Date) the Unit Identifying Numbers, the Assigned Street Addresses, and the Tax Parcel Identification Numbers below.
